Voluntary Release, Waiver, Assumption of Risk, and Indemnity Agreement ("Agreement")

In consideration of my participation in the Salmon Run sponsored by Patagonia, Inc., to be held at the Ventura River floodplain and the Lost Arrow Corporation facilities, and all activities associated therewith (the "Event"), the undersigned for myself, my personal representatives, heirs, next of kin, spouse and assigns DO HEREBY:

- 1. Release, Discharge and Covenant NotTo Sue Lost Arrow Corporation, Patagonia, Inc., all of their affiliated and subsidiary companies, their officers, directors, agents, Trustees, contractors, employees, shareholders and insurers (all collectively referred to herein as "Releasees") from any and all claims, loss, liability, damages, or expense related to the Event in any way, arising out of any wrongful or negligent acts or omissions on the part of Releasees or any other person or any other cause whatsoever, which may cause me injury, death, damages of any kind. I hereby covenant to defend Releasees, hold Releasees harmless, and to indemnify Releasees for any claim, loss, liability or expense (including, without limitation, attorneys' fees and costs which Releasees, or any of them, may incur) in connection with the Event or arising out of my activities.
- 2. Understand that running, walking or participating in a foot race is a potentially hazardous activity. My participation is voluntary and I Voluntarily Elect to Accept All Risks connected with my participation, including, but not limited to falls, contacts with other participants, the effects of the weather, including high heat and/or humidity, traffic and the conditions of the road, all of such risks being known and appreciated by me.
