## Dear Interested Party:

The Los Padres National Forest is initiating an environmental analysis to re-issue a campground concessionaire special use permit for operating and administering government owned developed recreation facilities. The Forest Service is requesting comments on the proposed action. This scoping period provides an opportunity for those interested in or affected by the proposal to make their concerns known prior to a decision being made by the responsible official.

## BACKGROUND / PURPOSE AND NEED

Concessionaire management of recreation facilities has been in place on the Los Padres National Forest since 1995. Forest Service recreation sites managed by concessionaires are campgrounds, day use areas, and trailheads.

The purpose of this analysis is to evaluate re-issuing a special use permit for operating the recreation facilities. The Los Padres currently has six separate concessionaire special use permits and all of them are expiring. Concession permit operation of government-owned facilities is authorized by Section 7 of the Granger-Thye Act, 16 U.S.C. 580d. This activity is consistent with the Land Management Plan/Los Padres National Forest Strategy REC 3: Maintain partnerships with business who operate and maintain existing recreation facilities under the concession program to meet the needs of visitor demands.

## PROPOSED ACTION

The special use permit will allow the concessionaire to provide public service in the operation and maintenance of government furnished recreation facilities as directed by the Forest Service. The context of the special use permit is operational and administrative and does not provide authorization for any ground disturbing activities, changes, or physical alterations to the recreation sites. The scope of operation and capacity of the recreation facilities would not change by this action. Any ground disturbing activities will be evaluated on an individual case by case project bases.

The proposed action would move all the concession operated sites under one special use permit. An additional number of sites not currently under concession management are proposed for inclusion in the new permit. See Table 1 for a list of recreation sites.

The proposed action may be categorically excluded from documentation in an environmental assessment (EA) or environmental impact statement (EIS) if a proposed action fits within a category listed in 36 CFR 220.6, and if there are no extraordinary circumstances. The preliminary assessment indicates there are no potential effects that result in extraordinary

circumstances, and the proposal fits with the following category: repair and maintenance of roads, trails, and landline boundaries. (36CFR 220.6(e)(15).

## SUBMITTING COMMENTS
